CPA OUTREACH INITIATIVES

On 21st November 2024, a significant step towards strengthening professional development opportunities for accounting students took place at the Faculty of Accountancy, Universiti Teknologi MARA (UiTM) Melaka. We welcomed a delegation from CPA (Australia) for an introductory meeting. The session was led by Mr. Izzuan Rosli, Business Development Manager (Malaysia), the Global Member Experience from CPA Australia, who expressed keen interest in establishing a collaborative partnership between the esteemed professional body and the university especially in Melaka branch.



The meeting was attended by several key members of the faculty's management team, including Dr. Nor Aishah Mohd Ali. Discussions focused on the pivotal role of CPA (Australia) in shaping the future of the global accounting profession and its commitment to developing highly competent business professionals.



During the session, Mr. Izzuan proposed various initiatives aimed at raising awareness among students about the value of CPA (Australia) qualifications in the competitive job market. A primary suggestion included the appointment of student ambassadors to serve as campus representatives for CPA (Australia). He also outlined plans for a series of outreach programs designed to provide students with deeper insights into the advantages of obtaining a CPA certification.

Another notable highlight of the meeting was the discussion on financial assistance schemes available to students interested in enrolling in the CPA (Australia) program. These initiatives are expected to encourage more students to pursue internationally recognized professional qualifications, thus enhancing their employability.

EMPOWERING EFFECTIVE STRATEGIC PLANNING

On 28th January 2025, as an effort to strengthen strategic planning and enhance Universiti Teknologi MARA (UiTM)'s performance, the Faculty of Accountancy, UiTM Melaka, successfully conducted Bengkel Perancangan Strategik (BPS) Tahun 2025 Fakulti Perakaunan UiTM Cawangan Melaka (FPN UiTMCM) at Smart Classroom, Ground Floor, Bangunan KPP2, UiTM Melaka, Alor Gajah Campus. The workshop brought together the entire faculty members, fostering a collaborative environment to align with UiTM's latest performance targets.

As part of UiTM's commitment to continuous improvement and strategic excellence, the faculty was officially assigned specific Performance Indicators (PIs) for the year 2025.

To ensure effective execution, the workshop focused on developing comprehensive strategies to achieve these targets through structured discussions and collaborative planning.

The primary objective of the workshop was to strengthen faculty members' understanding of the latest Operational Definitions (OD) and the distribution of PIs that have been assigned to UiTM Melaka. With UiTM's commitment to continuous improvement and academic excellence, the session served as a platform for faculty members to familiarize themselves with the updated requirement and expectations.

Engaging and Productive Sessions

The workshop began with an ice-breaking session, designed to foster better communication and teamwork among faculty members. Faculty members were then divided into groups according to their respective bureaus to brainstorm potential programs and initiatives that could contribute to achieving the PIs goals. In addition, during the bureau's discussion, they need to appoint bureau heads.

In the afternoon session, each bureau presented their proposed programs and activities, receiving valuable feedback from Head of Study Centre (KPP) and fellow participants. These discussions proved to be highly insightful, allowing faculty members to refine their strategies and strengthen their proposed initiatives.

Following the presentation, all bureaus finalized their tentative plans, filling in templates provided by the faculty to outline key programs for the year. The workshop concluded with the preparation and submission of working papers for approval, ensuring that all proposed activities align with the faculty's strategic vision.



Financial Support for Implementation

To support the execution of these initiatives, UiTM Melaka has approved a budget of RM520 for the organisation of the workshop. This funding is expected to facilitate the faculty's efforts in achieving its PIs and further enhancing academic and operational excellence.

The initiative underscores UiTM Melaka's dedication to fostering a culture of excellence, ensuring that faculty members are well-equipped to contribute towards the institution's strategic goals. MASTERING INDEXED ARTICLE COMPOSITION – FPN 2024

The Writing and Publication Bureau, Faculty of Accountancy, UiTM Cawangan Melaka has undertaken a strategic initiative in achieving its research and publication performance indicators (PI) that foster a stronger research culture among faculty members. Building on the positive momentum and achievements of index publication, the bureau has organized a program named “Mastering Indexed Article Composition – FPN 2024” workshop. This program was specifically developed to provide comprehensive exposure, practical guidance, and structured support for faculty members in composing articles suitable for indexed journals.

With the aim of increasing research productivity and publication quality, this workshop is an important step in helping lecturers meet their individual research PI as well as contributing to the faculty’s collective PI. The goal is to provide a cooperative and encouraging environment in assisting lecturers to enhance their publication index as main author or corresponding author for the year 2024. Furthermore, this initiative also intends to sustain the momentum of existing RIGs, ensuring they remain active in research and publication efforts aligned with the university's strategic goals.

This workshop was conducted in August and September 2024 where several lecturer who hold doctorates were allocated the role of mentors and others as mentees. The outcome of the workshop was encouraging and demonstrated tangible progress toward the faculty’s objectives. Several lecturers successfully developed and refined draft manuscripts and prepared their work for submission to indexed journals. JULY 2025 AC220 VETTING WORKSHOP

The Faculty of Accountancy at Universiti Teknologi MARA (UiTM) Cawangan Melaka, Alor Gajah Campus conducted a one-day event titled "Vetting Workshop for Final Examination Question Papers and Marking Schemes for the July 2025 Final Examination" on 28 February 2025, from 8:30 am to 5 pm. This workshop includes peer reviews and guided discussions based on the prepared documents following the examination requirement as set by the Faculty of Accountancy Anchor Campus in UiTM Puncak Alam, Selangor.

The session was specifically attended by lecturers in the Bachelor of Accounting (AC220) program who have been appointed as paper setters and vetters for the upcoming examination session. The list of codes for Bachelor of Accountancy required for vetting are classified into three main subfields:

1. Financial Accounting and Reporting
2. Management Accounting and Finance,
3. Taxation, Auditing, and Corporate Governance.

The primary focus of this workshop is to ensure that all final examination materials — including question papers and marking schemes — are developed in accordance with the required academic standards and institutional policies. This includes adherence to the Test Specification Table (Jadual Spesifikasi Ujian - JSU) and the examination guidelines outlined by the Academic Assessment and Evaluation Division (BPPA), UiTM Shah Alam.

The workshop was held with the following objectives:

1. To enhance the quality of the examination question papers and marking schemes prepared by faculty members.
2. To ensure full compliance with guidelines provided by BPPA and the Faculty of Accountancy.
3. To provide a collaborative platform for peer collaboration, allowing paper setters and assessors to refine, and improve the examination materials.
4. To minimize technical and content-related errors, thereby ensuring the readiness of documents before official submission and printing for final examination questions.

At the conclusion of the workshop day, the Faculty of Accountancy, UiTM Cawangan Melaka, submitted all vetted question papers via email to the Anchor Campus Faculty of Accountancy Puncak Alam for further assessment and approval.

The faculty is confident that through this structured and collaborative vetting process, the integrity and quality of the assessment system will further be strengthened, in line with UiTM's academic standards and expectations.



JULY 2025 AC110 VETTING WORKSHOP

The Faculty of Accountancy, UiTM Melaka Branch, Alor Gajah Campus conducted a one-day workshop of Bengkel Pentaksiran Kertas Soalan dan Skema Jawapan bagi Peperiksaan Akhir Julai 2025 Diploma Perakaunan (AC110) Peringkat Fakulti Perakaunan UiTM Cawangan Melaka at the faculty level. This workshop was conducted on 4 March 2025 (Tuesday) in conjunction with the deadline for the exam question set to be submitted to Faculty of Accountancy, UiTM Johor as the Pengurus Utama (PU) for AC110 programme. The workshop was conducted at Bilik Mesyuarat Pejabat Fakulti Perakaunan.

Through this workshop, AC110 lecturers from the Faculty of Accountancy at the Alor Gajah Campus - appointed as Question Setters and Vettors underwent the process of evaluating and improving the quality of the final examination questions and answer schemes based on Jadual Spesifikasi Ujian (JSU) and Garis Panduan Proses Penyediaan Kertas Soalan dan Skema Jawapan Peperiksaan UiTM, issued by the Bahagian Pentaksiran dan Penilaian Akademik (BPPA), UiTM Shah Alam.

Beside the vetting process, the workshop initially included a hands-on session of Question Bank System (QBS) for the participants. The respective session was limited to only briefing on the introduction of the system.

The management of the Faculty of Accountancy has emailed the examination questions and answer schemes to the PU AC110 before the designated deadline.



FPN 2025 AL-QURAN TADARUS PROGRAM AND KHATAM CEREMONY

The Al-Quran Tadarus program and Khatam ceremony of the Faculty of Accountancy (FPN) UiTM Melaka is an annual activity held during Ramadan. For Ramadhan 1446H, Biro Pembangunan dan Kebajikan Pensyarah (BPKP) was entrusted to organize the activity. The period of the Al-Quran Tadarus program commenced on Wednesday, 5 March 2025, and ended on Wednesday, 19 March 2025.

The activity was aimed to promote the culture of reciting Al-Quran during the month of Ramadhan while providing a platform for the participants to improve their skills and competency in the recital of the Al-Quran. Besides, it may also foster closer relationships among the lecturers of the Faculty of Accountancy (FPN), UiTM Melaka. Altogether, 42 accounting lecturers participated in the program.

The accounting lecturers who participated in the program were divided into 21 pairs. Each pair was assigned to read approximately one to two juzuk (sections) of the holy Quran. It was a common practice that the recital of the Quranic verses by a particular lecturer would be duly checked or verified by his or her partner. The practice is to ensure that the Quranic verses are read properly and that there is no distortion of words or verses during the recital of the Quran. Each pair of participants in the Al-Quran Tadarus group was given approximately two weeks to complete the recitation of the allocated juzuk of the holy Quran.



To signify the completion of the Al-Quran Tadarus program, FPN UiTM Melaka had organized the Al-Quran Khatam ceremony on 19 March 2025 at the Muslim prayer room of the Kompleks Pentadbiran dan Pembelajaran (KPP) 1. Most of the FPN UiTM Melaka lecturers participated in the program.

JOB SCAM: HOW TO SPOT AND AVOID EMPLOYMENT FRAUD – A WEBINAR

On 18 October 2024, a webinar sharing session is organized by the Money Laundering Research Group (MLRG) of UiTM Melaka branch, in collaboration with the Management Accounting and Innovation Research Interest Group (RIG) of UiTM Melaka branch and the Royal Malaysia Police (Commercial Crime Investigation Division).

The webinar aims to share knowledge on scams, which are increasingly reported in social media and news outlets. This was done to address the recent rise in scam activities and to expose students and parents to the situation. The nation will face greater risks if the public remains unaware of this issue. Therefore, MLRG has taken the

initiative to explore this topic by bringing together credible and authoritative institutions and the Royal Malaysia Police to raise public awareness. This effort is particularly focused on tackling the issue of 'Job Scams' and controlling such crimes within the country.

The webinar served as a platform to cultivate a knowledge-sharing culture and exchange valuable experiences to raise public awareness about scam crimes to prevent their continued occurrence. It provided the public with insights into the latest financial crimes and offered relevant advice from authoritative bodies to help curb such crimes.

During the sharing session, the speaker highlighted some of the famous job scams on the rise in Malaysia, targeting job seekers through various deceptive means. Some common types of job scams highlighted by the speaker include:

1. Overseas Job Scams

These scams lure victims with promises of high-paying jobs abroad, particularly in countries like Thailand, Cambodia, Myanmar, and Laos. They are often required to make advance payments for travel expenses, work permits, or visa processing. Only when they are compelled to engage in illicit activities such as human trafficking, scam call centers or modern slavery do the victims realize it.

2. Fake Work-From-Home Jobs

Scammers propose high-paying, simple internet occupations (such as affiliate marketing and data input) to attract victims. In most cases, the victims seldom get actual jobs, but they must pay an upfront registration or training cost. Some schemes involve "task completion" models, in which victims are paid at first but lose more money afterward.

3. Commission-Based Scams (Easy Money Jobs)

In this type of scam, victims are recruited to "boost" sales by purchasing products or services upfront. They are promised commissions but eventually lose money when the scheme collapses. This commonly happens in Telegram or WhatsApp job offers.

4. Fake Recruitment Agencies

Victims are charged by fraudulent organizations for resume processing, interviews, or job placements. The agency either offers phony employment offers or vanishes after payment.

5. Impersonation Scams

Scammers pose as reputable businesses or governmental organizations. The agencies will use chat apps, social media, or email to send phony job offers. The victims are asked to cover the cost of background checks, training, or clothes.

6. Pyramid Scheme Jobs

In this scheme, victims commit money upfront but find it difficult to attract others, resulting in financial losses, and they must recruit new members to receive commissions rather than selling real goods or services.

7. Freelance or Part-Time Job Scams

Platforms that offer large compensation for jobs like writing, designing, or video editing were developed by scammers. The victims are asked to purchase tools or software or pay membership fees. Some people are assigned fictitious assignments but never get paid.

8. Job Offer with Personal Data Theft

Through bogus job applications, scammers obtain victims' personal information (IP, bank account details, etc.), which is then used for identity theft, fraudulent lending, and other crimes.

Additionally, the speaker counsels the audience to steer clear of employment scams, always confirm job advertisements on official corporate websites, refrain from paying upfront fees, and be wary of offers that seem too good to be true. The following actions might be performed to safeguard yourself if you believe that you are the victim of an employment scam:

1. Stop All Communication with the Scammer

This can be accomplished by banning the scammer's phone number, email, and social media accounts, as well as by refusing to provide any further money or personal information.

2. Verify the Job Offer

One way to confirm the job offers is to visit the company's official website, look for job openings on the careers page, call the company using official contact information rather than the one provided by the recruiter, and look for reviews and scam reports by looking for warnings from previous victims.

3. Report to Authorities

These are some of the authorities the victims of the scam activities can report to:

- Royal Malaysia Police (PDRM) – Lodge a police report at the nearest station.
- Cybersecurity Malaysia (CSM) – Report online scams via www.cybersecurity.my
- Bank Negara Malaysia (BNM) – If financial fraud is involved, contact BNM.

·Ministry of Human Resources (JTKSM) – If an agency is involved, report to the labour office.

·SCAM Response Centre (CCID PDRM Hotline: 997) – Available to report financial scams.

4. Alert Your Bank (If You Have Transferred Money)

If you have made payments to scammers, contact your bank immediately to freeze or track the transaction.

5. Warn Others to Prevent More Victims

Share your experience on social media and community forums. Inform family and friends so they don't fall for the same scam.

6. Monitor Your Personal Information

If you have disclosed sensitive information (such as your passport, bank account, or identification number), make sure that your personal information is being monitored. You should also keep an eye on your credit score and financial accounts for any unusual behaviours.

In conclusion, you should study the activities and learn how to identify job scams to prevent them. You should also be wary of big incomes that require little work. Steer clear of positions that demand payment in advance, and before you begin working with a recruiter or company, confirm their legitimacy with official sources. Trust your gut and perform extensive study before accepting a job offer if you're ever hesitant!

BRIDGING THEORY AND PRACTICE: RISK AND RETURN WITH INDUSTRY INSIGHTS






The event resulted in several positive outcomes. First, it enhanced student engagement and understanding, where the students demonstrated increased interest and comprehension of the subject matter. In addition, the feedback and assessment results indicated improved student performance and engagement. The outcomes highlighted the effectiveness of co-teaching in enhancing student learning and professional development for educators. 



All 158 students from UiTM Melaka completed the module with excellent results which contributed to the outstanding grade for AIS 655.

This important workshop helps bridging formal classroom and virtual classroom delivered by the industry experts. The workshop is designed to bridge the gap between academic learning and real-world applications. As businesses increasingly rely on data to make strategic decisions, accountants must evolve beyond traditional roles to become data-savvy professionals. This collaboration between PwC and Faculty of Accountancy UiTM is a testament to the commitment to nurturing future-ready accounting graduates. As students continue to embrace data analytics, they are poised to become the next generation of industry leaders, driving innovation and efficiency in financial practices as well as competent accounting practitioners.



On 15th January 2025, a collaborative teaching session titled "Financial Market Analysis and Risk Assessment: Industry Perspective" was successfully conducted online Google Meet as part of an initiative to strengthen students' practical understanding of financial instruments and risk management concepts. The session was made possible through the efforts of a dedicated team of lecturers from the Faculty of Accountancy: Dr. Sharifah Norhafiza Syed Ibrahim, Dr. Nor Aishah Mohd Ali, Ms. Siti Azrina Adanan, Ms. Khair Syakira Bustamam, and Mr. Mohd Tarmizi Ibrahim.



This session was targeted specifically at students enrolled in a few faculty core courses: Seminar in Management Accounting (MAF651), Internal Auditing (AUD679), Financial Statement Analysis (FAR670), and Financial Accounting and Reporting 4 (FAR570). It aimed to provide a deeper understanding of financial market dynamics and risk assessment through real-world industry applications.


The guest speaker, Mr. Muhamad Afendi Md Yassin, an industry expert in financial market instruments and risk assessment with a strong background in the oil and gas sector, brought invaluable industry insights to the students. During the 2-hour session, he shared his experience in implementing internal controls and evaluating potential operational risks, drawing examples from high-risk industries to illustrate the importance of robust financial oversight and risk mitigation strategies. With more than 20 years of working experience in international companies, including serving as the regional director, he imparted valuable experience in dealing with market risks and disclosed few of his best practices in risk assessment.

This valuable session was a golden opportunity for students to learn beyond the classroom. Students were actively engaged with the speaker, posing insightful and critical questions regarding real-world risk management practices. The discussion sparked thoughtful dialogue on how industries identify, assess, and respond to financial risks, and what role financial professionals play for businesses to sustain.



The session concluded on a high note, with positive feedback from both students and faculty members. The interactive nature of the session not only enhanced academic learning but also ignited student interest in the practical aspects of risk management. It successfully bridged the gap between theoretical knowledge and industry practice, encouraging students to think beyond textbooks and engage with real-world challenges.

This session reflects the faculty's ongoing commitment to incorporating industry engagement into the academic curriculum and nurturing future financial professionals who are well-equipped to navigate the complex financial landscape.




The seminar featured an insightful presentation by Tuan Mohamed Inmran Bin Sahul Hamid, Deputy Director of the Internal Tax Division, RMCD Perak, who shared his expertise and practical knowledge on Malaysia's Sales and Service Tax framework. The program was further supported by the presence and involvement of six lecturers: En Mohd Amran Mahat, En Azlan Md Thani, Dr. Rani Diana Othman, Puan Afidah Sapari, Cik Siti Anis Nadia Abu Bakar, and Puan Nur Quratun 'Aini Haron, ensuring smooth coordination and active student engagement throughout the session.

This Taxation Seminar represents a collaborative teaching initiative between the university and industry, fulfilling the university's commitment to enhancing the teaching and learning process through industry engagement. By involving the Royal Malaysian Customs Department (RMCD) in this program, students were given the valuable opportunity to gain real-world insights into the administration and management of indirect taxes in Malaysia. The session not only enriched students' academic understanding with practical industry knowledge but also served to strengthen linkages between Universiti Teknologi MARA (UiTM) and RMCD, fostering ongoing cooperation and mutual support in developing future-ready graduates.



From the survey conducted on the feedback of the program, most of the students were satisfied with the program, and they believe that the program has increased their understanding and knowledge on the Indirect Tax topic and issues. - Increased Confidence: Participants displayed a 'More Confident' level in applying photography skills.

- Potential for Income Generation: The program inspired participants to consider their photographic works as a source of income through online platforms.

In summary, this collaboration not only enriched the participants' skills but also laid the groundwork for future initiatives aimed at enhancing community engagement and development.



STRATEGIC PLANNING MEETING FOR FORM 4 MATHEMATICS PERFORMANCE INTERVENTION PROJECT

The Strategic Planning Meeting for Form 4 Mathematics Performance Intervention Project under the Teja Community Grant (GKT) 2025 with the theme “Community Engagement Through Academic Enrichment” was held on 25 February 2025 at the Faculty of Accountancy Office, Universiti Teknologi MARA (UiTM) Alor Gajah Campus. The meeting discussed proposals to provide free Mathematics tuition for Form 4 students from the Tangga Batu parliamentary community, a semi-urban area, who demonstrate potential but come from underprivileged backgrounds. This community was selected to ensure greater educational equity for students facing socio-economic challenges with limited access to paid tuition classes.



The meeting was chaired by the Project Leader, Dr. Nor 'Asyiqin Binti Abu, with the attendance of seven lecturers from the Faculty of Accountancy (FPN) and four committee members from Global Peace Mission (GPM) Melaka. The key agenda items discussed included:

- Tuition Schedule: Classes are set to commence on 19 April 2025, consisting of 14 sessions held twice a month for three hours at the Community Learning Centre, Tanjung Minyak, and the Smart Classroom, UiTM Alor Gajah Campus.
- Participant Selection: A total of 20 Form 4 students from underprivileged families with low Mathematics achievement will be selected by GPM Melaka.
- Modules and Methodology: Learning modules in Bahasa Melayu will be developed by lecturers from the Faculty of Computer Science and Mathematics (FSKM). Each session will comprise 1-hour lectures and 2-hour group exercises, facilitated by 2 to 4 lecturers.
- Project Funding: The project will be fully funded by the Teja Community Grant (GKT), covering travel expenses, research materials, community activity supplies, and journal publication fees.
- Research and Publication: Committee members are encouraged to conduct research related to the project and publish their findings in ERA-indexed journals.
- Strengthening Bonds and Ethical Values: Activities aimed at enhancing motivation and instilling ethical values among participants are also planned.
- Learning Equipment: Stationery sets, printed materials, and learning tools will be provided for both participants and lecturers.
- Memorandum of Understanding (MoU): A proposal for an MoU between FPN, UiTM Alor Gajah Campus and GPM Melaka to strengthen collaboration in future community projects, particularly in the academic intervention and community empowerment sectors.

The project is expected to improve students' academic performance in Mathematics while cultivating ethical values and good manners among participants. The project's success will be measured based on students' improved Mathematics scores in examinations, class attendance rates, and feedback collected through student surveys. Additionally, a follow-up assessment will be conducted three months post-programme to gauge long-term academic progress.

COMMUNITY ENGAGEMENT THROUGH ACADEMIC ENRICHMENT

The year 2025 commenced positively for the Faculty of Accountancy, which received the Teja Community Grant from the Research & Industry Linkages (PJI) at Universiti Teknologi MARA (UiTM) Melaka Branch. Each grant recipient, with an allocation of RM5,000, is responsible for executing a community-based project designed to enhance the university's societal engagement, fulfil the University Social Responsibility (USR) agenda, and ensure that knowledge transfer initiatives produce measurable benefits for the community.

According to the Programme for International Student Assessment (PISA) 2022, Malaysian 15-year-olds achieved a score of 409 in Mathematics, markedly lower than the OECD average of 472 (OECD, 2022). Given these findings, our team has decided to concentrate on empowering Form Four secondary school students in mathematics, as they are at an important stage of academic development.



On Saturday, 19 April 2025, a five-member grant team led by Dr. Nor 'Asyiqin Abu, along with Dr. Nor Aishah Mohd Ali, Madam Zaharah Abdullah, Madam Wan Shafizah Hussain, and Madam Enylna Nordin, in collaboration with four executive members from the Member of Bachelor Accountancy (MEBA) student body, successfully organised the Kickstart Pro Maths 2025 Programme at the Community Learning Centre (CLC), Tanjung Minyak. The initiative assembled 18 Form Four students from schools in the Tanjung Minyak neighbourhood. These pupils were meticulously chosen for involvement in an 18-week intensive mathematics training program planned for 2025. Priority was accorded to students who achieved below 50% in their Form Three mathematics examinations and those from low-income B40 households.

The program began with a concise presentation by a representative from Global Peace Mission (GPM) Melaka, detailing the objectives and vision of the Pro Maths Programme. An informal ice-breaking activity was thereafter held by MEBA students to facilitate early rapport among participants from various schools. A primary activity was the “Wheel of Multiplication” a collaborative game aimed at reinforcing fundamental multiplication abilities. The students relished the competitive environment as they hurried to finish multiplication assignments swiftly and precisely.

A notable aspect of the day was an inspiring lecture by Dr. Nor ‘Asyiqin Abu, who underscored the essential function of mathematics as a “bridge to higher education.” She elucidated the difficult academic environment, highlighting that although more over 100,000 students obtained A+, A, or A- grades in SPM Mathematics in 2023, only approximately 70,000 places are available in public universities. Strong performance in Mathematics is essential not only for university admission but also for entry into key disciplines such as medicine, engineering, accounting, and computer science. Moreover, skill in mathematics is a critical factor for obtaining scholarships.

Dr. Nor Aishah Mohd Ali, assisted by other grant members, administered a focused questionnaire to gain insights into the students' academic backgrounds and issues. The objective was to ascertain the underlying causes of their challenges in mathematics and to comprehend their expectations regarding the Pro Maths program.

The program completed smoothly at approximately 11:45 a.m., following a productive and energetic session that began at 8.30 a.m. The students' enthusiasm and active participation signalled a strong and promising commencement of the Pro Maths 2025 campaign.

GRANT AND RESEARCH OPPORTUNITIES: EMPOWERING ACADEMIA

The seminar covered essential topics like Pooled OLS, Fixed and Random Effects, Hausman tests, and even advanced techniques like Difference and System GMM (Arellano-Bond). What stood out most was the practical guidance on selecting the best model and addressing endogeneity using GMM - a lifesaver for my thesis work! Beyond the technical value, it was great connecting with fellow researchers and enjoying Penang's famous food scene during breaks. If you're working with panel data and want to sharpen your econometric skills, I highly recommend this seminar. It turned complex techniques into something I could actually apply with confidence.

CGCT FAR410 & FAR270: INVENTORY MANAGEMENT MODEL 2: DELIVERY COLLABORATION



On 13 March 2025, a Collaborative Teaching (CT) session was successfully conducted involving students from the Faculty of Accountancy, Universiti Teknologi MARA (UiTM) Melaka. This initiative brought together students from two core accounting courses—FAR270 (Financial Accounting 3) and FAR410 (Financial Accounting and Reporting 1)—in an interactive and insightful online session via Google Meet. The program aimed to enhance students' understanding of financial accounting frameworks and reporting practices in line with Malaysian Financial Reporting Standards (MFRS) focusing on MFRS102 Inventory.

The highlight of the session was a guest lecture delivered by Ms. Nur Baiti Binti Shafee, a lecturer from the Faculty of Business at Multimedia University, Melaka. With extensive experience in accounting education and research in corporate governance and financial reporting quality, Ms. Nur Baiti shared valuable insights into the real-world application of accounting principles. She provided a comprehensive explanation of the preparation and presentation of financial statements, focusing on compliance with MFRS 101 and other relevant standards.

Introduction


On 17 October 2024, PTAR UiTM Cawangan Melaka hosted an Information Literacy class designed to enhance students' research capabilities. Conducted virtually via Google Meet, this session focused on navigating online databases, an essential skill for academic research. The class aimed to move beyond traditional lecture formats, engaging students in interactive and hands-on learning to better equip them with the tools necessary for independent research.


The session was initiated by Miss Salina Abdullah, a teaching lecturer of the FAR661 course from Faculty of Accountancy. She took the initiative to book the session through the online booking system, ensuring that her students would gain practical skills in navigating the library's online resources. The session was led by Cik Hazlin Ibrahim Khan, a senior librarian at PTAR UiTM Cawangan Melaka, who provided expert guidance throughout. A total of 25 students from MAC 220 6A and 6B group, Faculty of Accountancy, participated in the session.

Session Overview

The session provided a practical, hands-on approach to using online databases—an indispensable resource for academic research. Rather than listening to a lecture, students engaged directly with databases, learning how to efficiently search and retrieve relevant academic materials. This active participation fostered deeper understanding, as students could immediately apply what they learned under the guidance of Cik Hazlin, who demonstrated effective search techniques and answered students' queries in real-time.

This format allowed students to grasp the real-world application of online research tools, empowering them to use these resources independently for completing their group project. The focus on databases was particularly relevant for accounting students, who need access to a variety of academic journals, industry reports, and research papers subscribed by the library.





Importance of Library Resources

A key takeaway from the session was the importance of leveraging the extensive resources available through PTAR UiTM Cawangan Melaka. Many students are not fully aware of the full range of digital tools and materials offered by the library, including online databases, e-books, peer-reviewed journals, and research publications.

The session highlighted the significance of using high-quality, reliable resources such as Scopus and Web of Science—tools that provide access to peer-reviewed articles and academic journals not readily available through general internet searches. By familiarizing themselves with these databases, students can enhance the quality and depth of their group project written report. Understanding how to navigate these platforms ensures that students can find the right materials to enhance their academic work, contributing to higher-quality research.

Booking Information for Future Sessions

To support the ongoing development of information literacy skills, PTAR UiTM Cawangan Melaka offers a range of modules tailored to meet the diverse needs of students, lecturers, and postgraduates. These modules cover fundamental and advanced research techniques, reference management software, and more.

PRE-EXAMINATION MEETINGS BETWEEN THE MAC1101E GROUP OF STUDENTS AND THEIR ACADEMIC ADVISOR

On 22 January 2025, an informal meeting was held between the MAC1101E group of students and their Academic Advisor, En Jismi Md Salleh, also known as PAPA among the students. The meeting, which started at 10.15 am, was initiated by the students who aimed to get the necessary advice from their Academic Advisor regarding their studies and strategies to enhance their performance in the final examinations.

Among the issues raised by the students in the meeting were the problem of answering theoretical or essay-type questions requiring critical thinking and writing skills. Most students admitted that they always face difficulties answering theoretical questions, although they understood the concepts and content well.




Concerning the issues raised by the students, the Academic Advisor shared a few tips on how the students may overcome their problems with the theoretical questions. The students were advised to read the textbooks and other references thoroughly to obtain a firm grasp of understanding of the issues covered in the syllabus. While reading, they should try to jot down the keywords, key phrases, or important points from each paragraph or section. More importantly, the students should not disregard or ignore the theoretical questions in the final examination. Instead, they should attempt to answer the theoretical questions in their own words based on their understanding of the concepts and underlying principles.

In improving their writing skills, the students were advised to attempt questions from the previous years' examination papers. Doing so would expose the students to various theoretical questions tested in the real examination. Students should avoid trying to memorise all important content in the textbooks and reproduce it in the examination scripts. The Academic Advisor stressed that understanding the key concepts and principles is more important than memorising the content.

The students were also advised to care for their physical and mental health, especially during the examination week. They are reminded not to sacrifice their sleeping time for last-minute preparations or revisions so that they can stay focused and concentrate during the examinations. Last but not least, the students were reminded to always recite prayers and doa from time to time so that they will be blessed and guided by Allah in whatever they do. The students were also advised to seek the blessings from their parents or custodians before the final examination starts.

Before the end of the session, each of the students was required to identify and explain his or her weaknesses by sharing the answer in the class WhatsApp group. For each of the messages sent by the student, the Academic Advisor responded immediately by giving some comments and highlighting weaknesses in the answer. The Academic Advisor also suggested possible ways to improve the answers. Certain students were required to amend their answers until the Academic Advisor was satisfied with the answers. The purpose of the task was mainly to evaluate the students' ability to write answers to theoretical questions.

At the end of the session, a photography session was held at Dataran Ilmu, KPP 2, UiTM Alor Gajah, Melaka. The meeting ended at approximately 12.30 pm.



TEACHING ETHICS THROUGH COMICS: AN INNOVATIVE APPROACH TO THE MIA BY-LAWS FOR AUDITING SUBJECT (AUD689)

Understanding professional ethics is a fundamental part of any accounting education. For the Auditing subject (AUD689), there is a subtopic on Malaysian Institute of Accountants (MIA) by Law on professional ethics that needs to be covered. However, teaching the principles outlined in MIA By-Laws can sometimes feel abstract or theoretical to students. To make the learning experience more engaging and relatable, I have introduced an innovative classroom activity, using a comic strip assignment. Instead of asking students to simply read and summarize the MIA By-Laws, or attempt on final exam questions, I have challenged them to create a comic that illustrates a scenario involving ethical dilemmas among the auditors. Their task was to demonstrate how one or more of the By-Law principles such as integrity, objectivity, confidentiality, professional competence, or professional behavior are either upheld or violated in a real-world situation.

Why Comics?

Comics offer an inimitable way for students to think critically and imaginatively. Using comics, students are able to develop a storyline, dialogue, and graphics. In this assignment students can apply ethical concepts in context, form different perspectives, and communicate multifaceted ideas in a simplified, engaging format. The visual element helps students remember key points better, while the storytelling aspect increases their understanding of consequences and professional judgment.

How the Assignment Worked?

This assignment was given to part six students comprising classes MAC2206A, 6B and 6C (Semester Oct-Feb 2025). Students were given one week to complete their comic strip, using digital tools like Canva or Pixton. Each submission needed to include:

- Any section of Mia by Law particularly in section 400/500/600
- A short-written explanation of the ethical issue presented,
- A clear connection to the relevant MIA By-Law(s),
- Any threat to auditors' independence
- and a safeguard to minimize the threat to an acceptable level.

Student Reactions and Outcomes


The response I received was overwhelmingly positive. Students reported that the activity helped them to understand real ethical dilemmas of the By-Laws and made learning theoretical ethics more meaningful. The class also had a lively discussion when students presented their comics, sharing different interpretations and lessons. This engaging activity is able to bring more understanding towards the concept of MIA by Laws.

Reflections as an Educator


This creative approach helped transform theoretical subject particularly AUD689 from passive learning to an active, student-driven experience. Ethics isn't just about knowing the principles but recognizing dilemmas, thinking critically, and making reasoned decisions. It also allowed me to assess not just students' knowledge, but their ability to apply ethical reasoning in realistic contexts which can facilitate them in answering final exam questions.

Moving forward, I plan to include more creative, scenario-based tasks like this one and plan to compile these comic strips as an e-book for future references. Below are the examples of comic strips creatively created by the students:




